



## **« SERVICE » PARK REGULATIONS**

### **Locations**

Service park : Avenue Delchambre – 4500 Huy Parkings «  
Trailer parking : Avenue Godin Parnajon (Zone G) – 4500 Huy

### **Timetable :**

Access to the service park for installation:  
Saturday June 3, 2023 from 12:00 to 17:00.  
Access to the service park for disassembly: Sunday June 4, 2023, from 20:00 hrs.

### **Circulation :**

Access to the service park is only allowed with « SERVICE » passes.  
The circulation of assistance vehicles is forbidden during the passage of the competitors.  
However, in the event of abandonment or disqualification, the « SERVICE » vehicles concerned may leave the service park after autorisation by the service park manager. They may not – in no case – constitute a hindrance to competitors still racing.

### **Dimensions :**

Each competitor will have a space of 8 metres in front.  
If a « team » provides assistance to several cars, it will be given an additional space of 5 metres per additional vehicle (i.e. 13 metres for 2 cars, 18 metres for 3 cars, etc.).

### **Localisation :**

The organiser will mark out the assistance sites.  
The organiser will inform each competitor of the location of his "assistance site" when the material and documents are distributed on June 3, 2023.  
Location : IPES – Avenue Delchambre in Huy  
Any installation that does not respect the dimensions and assistance location assigned by the organisation will be dismantled and removed at the competitor's expense.

### **Access to the service park :**

- to the race cars ;
  - to assistance vehicles with a « SERVICE » plate to set up permanently for the period of the rally in the designated area and only 1 assistance vehicle per « team » ;
- All vehicles, trailers or structures installed must be removed and the waste evacuated by Monday

June 5, 2023 at 08:00h, in the entire service park.

### **Cleanliness on site :**

In the service park, it is compulsory to use **your own** rubbish bins and to take them back with you when you leave.

It is forbidden to leave tyres or pieces of glass.

### **« Fire » prevention**

In accordance with the provisions of the municipal fire prevention regulations:

- it is forbidden to use heating installations and cooking appliances with « open flame ».  
This includes « campingaz », barbecues, etc.
- the use of gas cylinders is PROHIBITED.

### **Music broadcasting**

The organisation will in no way be held responsible for the broadcasting of music - on a private basis - in the service park. The broadcasting of private music is subject to the same timetable as that of the organisation's marquee in accordance with the police decree in force.

Each competitor must comply with Belgian legislation (SABAM, "equitable remuneration", etc.) regarding the broadcasting of music in a place accessible to the public.

### **Electricity**

Electricity terminals are provided in the "Service" park on Avenue Delchambre.

It is up to the teams to provide sufficient wiring to reach their location.

### **REMINDER :**

As a competitor/crew member of the 2nd RALLY 4 PORSCHE - Huy, according to article 6 C of the special regulations, I commit myself to honour and be in solidarity with these points of the regulations.

The Organising Committee declines all responsibility for the consequences of the violation by competitors of the laws, regulations or provisions in force in the country; the responsibility for these acts and their consequences will be attributable only to the individuals who have committed or incurred them. The Organising Committee also declines all responsibility for riots, demonstrations, acts of vandalism, natural disasters, etc., or the consequences of such events, of which competitors may be victims. The payment of compensation, fines or penalties will be at their expense.
